4. Provisional No Objection Certificate will be subject to the approval of the statutory bodies of the University of Rajasthan.
5. In case the NCTE/state Government/University withdraws their recognition/provisional NOC/affiliation in respect of any college before granting approval of transition from the 4-year integrated Programme (B.A.-B.Ed/B.Sc.-B.Ed ) to Integrated ITEP Programme, the NOC so issued by the University to the concerned College (s) will stand cancel immediately.
6. Every and each college shall follow the directions of the NCTE /State Government/University failing which an appropriate action shall be taken accordingly.
